Comments: Ms. Simpson informed the board of two presentations for the Meeting. First, Melody Johnson-Williams, Executive Director, and Chuck Valentine, Director of Modernization and Development, for the Housing Authority City of Camden (HACC), addressing Resolution 05-10-23D. Resolution 05-10-23D is to authorize a Shared Services Agreement with the City of Camden so that the CRA, acting as the City's agent, would acquire by eminent domain seven privately-owned vacant and underutilized sites for a Phase IV housing development. The property would be acquired, pursuant to the City's statutory power under the Fair Housing Act and in furtherance of the redevelopment of the Ablett Village /CNI Grant.

And, secondly, Jonathan Compton, Executive Director of Center for Environmental Transformation, (CFET), will speak to Resolution 05-10-23E. Resolution 05-10-23E, CRA seeks authorization to convey CRA-owned property to CFET for an industrious community garden and environmental program. The CRA owned parcel is located on both sides by property owned by CFET. CFET years ago leased the property from CRA; and has since continued to use the site as part of a community garden.

Redevelopment Project Presentations

Ms. Simpson introduced Melody Johnson-Williams, Executive Director, and Chuck Valentine, Director of Modernization and Development, Housing Authority City of Camden (HACC). Ms. Johnson-Williams thanked the CRA Board of Commissioners for all of their support of the Ablett Village/Cramer Hill Transformation Plan, she asked Mr. Valentine to continue with an update to the board. Mr. Valentine discussed the need for sites suitable for acquisition and construction of 73 additional housing units. Mr. Valentine stated Phase I Off Site Family and II Senior housing projects are nearly complete. A Phase III will be constructed on the current Ablett Village site, providing for the demolition of 306-units and replacement of new 202-units on site. A total of 223 new units are called for in the off-site build-out. And, a total of 425-units overall. The sites selected for the Phase IV project are located (Site #1) across the street from Ablett Village and down from Mastery School, (Site #2) next to the Kroc Center, and (Site #3) along Harrison Avenue nearby the almost completed Senior development.

Mr. Valentine thanked the CRA and its Board of Commissioners for their continued assistance in acquiring land for CNI developments and adding to the City's affordable housing inventory. His remarks included thoughts on the transformational change that is taking place in the neighborhood with over \$500 million in leveraged development.

Ms. Simpson stated spoke to the need for the shared services agreement

Ms. Simpson asked Ms. Robinson-Rivera to introduce Mr. Johnathan Compton from CFET. Ms. Robinson Rivera stated she has been working with CFET for a little over a year regarding a property that is owned by CRA and is an active garden run by CFET. Mr. Johnathan Compton, Executive Director, Portia Simmons, Board Chair and resident, Cheryl Heatwave-Shank, Christoff Lindsey and Councilperson Shaneka Boucher spoke to the community garden as an iconic environmental initiative.

Mr. Compton gave a brief presentation on the property use in the Waterfront South neighborhood. CFET works with several groups and hires teenagers between 14- 17 years old to work in the garden. A wide variety of produce is grown annually, and once a week farm stands are stocked throughout the growing season. The garden serves as a classroom for the children, exposing them to a natural environment and growing of food. CFET also provides seedlings to others in the community for their gardens. CFET sells honey from beehives in the garden and hot sauce produced in support of the program. Over 2000 pounds of produce is grown, 66 farm stands are supported, and over 200 volunteers are involved in the program. About \$66,000.00 is generated annually to offset the estimated \$18,000.00 in costs necessary to maintain the garden. Mr. Compton reiterated the how significant and vital the community garden is to programming initiatives for youth in Waterfront South. CFET is excited to purchase the property and remain a steward of the garden.

The Ambient Group, LLC was the lowest responsible bidder for a contract to remove and properly dispose of more than 70,000 tons of contaminated soil from the Yaffa site. Ms. Gainey-Humphrey asked for clarification of the site, the amount of dirt and amount of the contract. Ms. Simpson indicated that the 618 Chestnut Street location was the largest of three soil piles to be removed (approximately 70,000 tons). The soil would be loaded-out of the site and disposed of to a NJDEP approval facility outside of the City. The Ambient Group will be under contract to follow the bid specifications for an approved work plan, transportation protocols and plan, and a safety plan for the scope of work.
