WHEREAS, CRA on Monday, February 27, 2023 received one proposal from a firm to perform the required services and has determined that the proposal of Mercadien, P.C. is responsive to the RFP, the firm is qualified to provide the services, and that the rates proposed are reasonable.

**NOW THEREFORE, BE IT RESOLVED** by the governing body of the City of Camden Redevelopment Agency that the Interim Executive Director of the Agency, a duly authorized representative of the Agency is hereby authorized to enter into a professional services agreement with the firm of Mercadien, P.C for the provision of auditing services for FYE December 2022 for the City of Camden Redevelopment Agency in an amount not to exceed \$40,500.00; and
