WHEREAS, the City of Camden Redevelopment Agency (the "CRA") is charged with the duty of redevelopment throughout the City of Camden (the "City"); and

WHEREAS, CRA is the owner of certain real property designated as Block 208, Lot 44 of the City of Camden Tax Map and described as 527 Broadway which 0.055-acre is improved with a vacant commercial structure (the "Project Site"); and

WHEREAS, CRA by Resolution #06-09-231E designated Urban Development Partners ("UDP") as the Redeveloper of the Project Site and provides the redeveloper designation will expire on October 29, 2021 if an acceptable redevelopment agreement is not executed or if the designation is not extended in writing by CRA prior to such deadline, and

WHEREAS, a redevelopment agreement was not entered into with UDP providing for the sale of the Project Site for the property's fair market value, CRA desires to terminate the UDP Redeveloper Designation for the Project Site and any related agreements with UDP.

- **NOW, THEREFORE, BE IT RESOLVED** by the governing body of the City of Camden Redevelopment Agency hereby terminates the designation of Urban Development Partners L.L.C. as Redeveloper of Block 208, Lot 44 of the City of Camden Tax Map and described as 527 Broadway; and
- **BE IT FURTHER RESOLVED**, the Interim Executive Director is hereby authorized and directed to terminate agreements with UDP relating to the redevelopment of the Project Site, if any, and
- **BE IT FURTHER RESOLVED**, the Interim Executive Director, or her designee, is hereby authorized and directed to take all actions and execute all documents necessary to carry out the purposes of this resolution.
