WHEREAS, the City of Camden Redevelopment Agency (“CRA”) is charged with the duty of redevelopment throughout the City of Camden; and

WHEREAS, Derek Davis retired from the CRA Board effective August 15, 2025, following a dedicated period of service commencing on May 20, 2020; and

WHEREAS, Mr. Davis has additionally demonstrated a commitment to representing the interests of the City of Camden’s residents and small business communities; and

WHEREAS, Mr. Davis carried out his responsibilities with diligence and passion; and

WHEREAS, it is appropriate from time to time for CRA to honor those individuals who have served the City of Camden with dedication and distinction.
