Ms. Simpson stated that the property is located in close proximity to Cooper University Medical School of Rowan University and the intended purpose is for conveyance to the Rutgers-Rowan Joint Board of Governors for the construction of a Health Sciences Building. Costs will be covered by a grant from New Jersey's Economic Recovery Board in 2015. CRA is completing this acquisition at the request of Cooper Health System to enable the seller to relocate in 2014.

Mr. Vasquez inquired about the anticipated reasonable costs. Ms. Simpson noted this would include: Title, Legal, and Appraisal expenses. Board Counsel Mark Asselta informed the Commissioners CRA is taking site control in order to maintain ownership to permit appropriate assemblage.

Mr. Vasquez asked if Staff costs would be covered. Mr. Asselta stated that the Redevelopment Agreement must be approved by CRA's Board and Staff costs can be part of the negotiation.

Commissioner Mirta Nieves requested further clarification on what the ERB grant will cover. Ms. Simpson reported it will cover purchase price, title insurance, legal costs, and board-up costs.
