In addition to the previously submitted written report, Executive Director Saundra Ross Johnson shared information about the temporary pop-up park at Roosevelt Plaza Park which was funded by the William Penn Foundation. The park, which includes colorful tables, chairs, shading, minor landscaping improvements, public art, and lighting, will be up until December 2015. Similar to other pop-up spaces in other postindustrial cities, the purpose of the park is to encourage residents, visitors, employees and students to spend time outside in the city and also to create safe public spaces in downtown.

Director Simpson added that the CRA worked with a consultant assigned and funded by HUD to assist with developing the RFP which is due October 3, 2014.
