Minutes of June 3, 2015 Monthly Caucus Meeting

Executive Director/Board Secretary Saundra Ross Johnson advised the board the final submission of minutes included the addition of votes for certain resolutions. In addition to the previously submitted written report, Ms. Johnson advised the Commissioners of the resignation of Project Manager Donna Helmes, following 12 years of service at CRA, to other employment. She reported that CRA is to be the recipient of four US Environmental Protection Agency grants of \$900k+. The grants will be managed by Economic Development Director James Harveson. A press conference is pending and all Commissioners will be invited to attend. It was noted that cashflow is very thin, but Directors are aggressively seeking to close deals. Staff is reduced to 10, but the same volume of work is being carried out. CRA needs to add staff and interviewing is underway. The Finance Committee will meet next week.

Executive Director's Report (cont'd)

PRESENTATION

Property Asset Manager/Project Coordinator-Redevelopment Sulena Robinson-Rivera was introduced. She presented an overview of CRA's Real Estate Asset Management Program. Substantial attention was devoted to the enhanced system of tracking properties. The goal is to execute redevelopment for the entire inventory.

Ms. Torres inquired about how the program relates to the recent finding of the auditor regarding property owned by CRA and asked how staff will ensure this doesn't happen again. Finance Director Johanna Conyers stated the incident occurred in 2005; however, recording of conveyance had yet to be done and the properties transferred to the CATO school project were carried on CRA's inventory list after transactions.

Ms. Conyer advised the Commissioners that the RAMP process, now, includes going back to 2003 when the CRA was re-instated and verifying that all conveyances are recorded by coordination with the tax collector and other departments. This will reduce the likelihood of additional findings.

Ms. Torres asked who maintains the land and stated this is critical, because the land is a liability.

Ms. Robinson-Rivera advised of a variety of methods: Housing Director Olivette Simson operates a

Clean & Green program and the 2015 baseline tour was conducted on June 2, City of Camden Department of Public Works (DPW), neighbors, and universities are among the resources.

Commissioner Javier Ramos inquired about how often the properties are cleaned. Ms. Robinson-Rivera reported CRA needs a funding source in order to issue an RFP so service can be expanded, adding that DPW assists when its schedule allows..

Commissioner Vance Bowman stated DPW is responsive to emergencies; it also operates a Quality of Life campaign.

Considerable discussion ensued regarding the feasibility of CRA creating and operating a service to sustain vacant parcels. The prevailing sentiment was that sustainability is important, however, the cost of employees is greater than the cost to maintain the properties through independent contractors.

Ms. Torres requested clarification on the term "reserved" status of properties on CRA's website.

Ms. Robinson-Rivera advised the Commissioner the term applies to properties for which Redevelopment Agreements/Targeted Projects exist.

Comments: This resolution was presented by Ms. Simpson. She advised the Commissioners that CRA has seven remaining grants with the NJ Economic Development Agency-Economic Recovery Board, require annual re-authorization. The proposed action parallels NJEDA-ERB's procedure.

As an example, Ms. Simpson advised the Commissioners that ERB grants cover planning and acquisitions in Whitman Park for the CHOICE project. Questions were posed by Mr. Bowman and Ms. Torres regarding elimination of funding for North Camden. Ms. Simpson advised the Commissioners that an award-winning plan for North Camden has been incorporated into the City's Master Plan.
