WHEREAS, the CRA received one (1) proposal from a firm to perform the required services; and

**WHEREAS**, the firm of Mercadien, P.C. responded to the Request for Proposals and submitted a proposal to perform the required work for a cost not to exceed \$39,060.00.

**WHEREAS,** the firm of Mercadien, P.C. has completed prior audits for the Agency and has provided other services to the Agency and is familiar with the books and records and the accounting procedures of the Agency and was deemed qualified to provide these services for FYE 2015.

**NOW, THEREFORE, BE IT RESOLVED** by the governing body of the City of Camden Redevelopment Agency that the Executive Director of the Agency, a duly authorized representative of the Agency, is hereby authorized to enter into a contract with the firm of Mercadien, P.C. for the provision of auditing services for the FYE 2015 for a cost not to exceed \$39,060.

**BE IT IS FURTHER RESOLVED**, that the Executive Director, or her designee, is hereby authorized and directed to take all actions and execute any and all other documents necessary to effectuate the purposes of this resolution.
