WHEREAS, the City of Camden Redevelopment Agency (CRA) is charged with the duty of redevelopment throughout the City of Camden; and

WHEREAS, the activities of the Agency requires administrative assistance with varying areas of expertise; and

WHEREAS, the CRA foresees temporary vacancies in its executive department, which have the responsibility for critical administrative and legal and real estate transactions; and

WHERAS, it is in the best interest of the CRA to utilize temporary employment services to assist in addressing these critical responsibilities; and

WHEREAS, the CRA issued a Request for Proposals (RFP) for the required services; and

**WHEREAS**, the CRA received two (2) proposals to perform the scope of work delineated in the RFP; and

WHEREAS, one of the proposers does not possess a valid N.J. Business Registration Certificate as required by law to provide services to a public entity; and

WHEREAS, Legal Medical Staffing Services, Inc. ("LMSS") was deemed qualified to provide the temporary employment services; and

WHEREAS, LMSS proposes to provide the required services on an hourly rate basis as set forth on a rate schedule submitted with its proposal; and

WHEREAS, the proposed term of the agreement is one year with the total amount of the contract not to exceed the amount of \$46,000.00; and

WHEREAS, under the proposed agreement CRA may use the temporary employment services on an as needed basis during the one year term.

**NOW, THEREFORE, BE IT RESOLVED,** by the governing body of the City of Camden Redevelopment Agency, that the Executive Director, a duly authorized Representative of the Agency, is hereby authorized to enter into a service agreement with Legal Medical Staffing Services, Inc. to provide temporary employment services for a term of one (1) year with services billed on an hourly rate basis for a total cost not to exceed \$46,000; and
