Resolution Authorizing a Shared Services Agreement with the City of Camden for the Providing of Finance-Related Support Services to the City of Camden Finance Department

WHEREAS, the City of Camden Redevelopment Agency ("CRA") is charged with the duty of redevelopment throughout the City of Camden; and

WHEREAS, N.J.S.A. 40A:65-1 authorizes local units of government to enter into agreements for shared services; and

WHEREAS, the CRA desires to enter into a Shared Services Agreement with the City of Camden to provide certain finance-related support services to the City of Camden Finance Department under Article VII of the City of Camden Code, including, Finance office, budget, and related entity budgets, as appropriate; and

WHEREAS, the City of Camden deems it necessary and appropriate to enter into a Shared Services Agreement with the CRA establishing the responsibilities of the parties, and the terms and conditions of the shared services;

WHEREAS, initial term of the shared services agreement will be for six (6) months, for an amount not to exceed \$20,000.00 with an option to extend the term of the Agreement for an additional six (6) months for an amount not to exceed \$20,000.00;

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the City of Camden Redevelopment Agency that the Interim Executive Director of the Agency, a duly authorized representative, is hereby authorized and directed to negotiate and enter into a shared services agreement with the City of Camden for the Agency to provide certain finance-related support services to the City of Camden Finance Department under Article VII of the City of Camden Code; and

BE IT FURTHER RESOLVED that the finance-related support services to the City of Camden Finance Department shall be provided by Johanna Conyer, an employee of the Agency, or such other employee of the Agency as designated by the Interim Executive Director, as described in the City of Camden Code under Article VII; and

BE IT FURTHER RESOLVED, that the Interim Executive Director, or her designee, is hereby authorized and directed to take all actions and execute all documents necessary to carry out the purposes of this resolution.
