Comments: Olivette Simpson, the Interim Executive Director, remarked the CRA in collaboration and partnership with the Housing Authority of the City of Camden (HACC) and others will submit a competitive Choice Neighborhoods Implementation (CNI) grant for up to \$35MM to the HUD, which is due in December 2020. The HACC and various partners completed a two-year process for the Cramer Hill Transformation Plan for redevelopment of the Ablett Village Public Housing site and the surrounding neighborhood. A key component of the Plan is to de-densify the Ablett Village housing development by building off-site in the neighborhood new housing. CRA has been asked to be the Neighborhood Lead under the application. Ms. Simpson introduced Victor Figueroa, Executive Director of the HACC.

Redevelopment Project Presentation

Victor Figueroa, Executive Director of HACC introduced his team, Chuck Valentine, Director of Modernization, Kevin Sheehan of Parker McCay, and Nick Cangelosi of the Michaels Organization.

Mr. Valentine briefed the board on the \$35MM CNI Implementation grant opportunity. He introduced the 5-phased housing component of the implementation grant. Specifically, the first two phases before the board include a 55-unit Senior development located below Harrison Avenue between 24th and 25th Streets and a 75-unit Family development near Veterans School. Applications for the Senior and Family developments will be submitted to the state to compete for low income housing tax credit financing. These housing developments will also support the Cramer Hill CNI Implementation grant application.

Chairperson Torres asked whether they have worked closely with the residents and whether the units will have washing machine & dryers, balconies, and a community center. Mr. Cangelosi advised, yes, but the project does not include balconies.

Director Simpson asked the HACC to speak to the Cramer Hill Transformation Plan.
