#### **Resolution Title:**

Resolution Authorizing a Subgrant from the U.S. Environmental Protection Agency Brownfields Revolving Loan Fund in the Amount of \$200,000 for the Environmental Cleanup of the Knox Meadows Phase II Site in the North Camden Brownfield Development Area (Block 746, Lots 26 & 46 and a Portion of Lots 17, 18, & 25 of the City of Camden Tax Map)

### **Project Summary:**

- A portion of the former Knox Gelatin Site is known as The Meadows at Pyne Point Phase II and is currently designated as Block 746, Lots 26 & 46 and a portion of Lots 17, 18, & 25 on the City Tax Map (the "Site").
- The Site is a City-owned property that is an active case with the New Jersey Department of Environmental Protection ("NJDEP") Site Remediation Program ("SRP").
- Prior to the planned residential redevelopment of the Site, the environmental contamination at the Site must be remediated in accordance with NJDEP SRP requirements.
- In 2013, the CRA with a grant from the Unities States Environmental Protection Agency ("EPA") established a Brownfields Revolving Loan Fund (RLF) to make loans and subgrants to fund environmental cleanup of brownfield sites in Camden.
- The EPA RLF program allows CRA to make subgrants to non-profits and other units of local government for eligible projects and uses.
- The CRA proposes an RLF Subgrant in the amount of \$200,000.00 to the City of Camden to fund a portion of the environmental cleanup of the Site.
- This Subgrant, along with a \$200,000 EPA cleanup grant awarded for the project, will serve to meet the match requirement for a grant of \$1,136,612 from the State Hazardous Discharge Site Remediation Fund (HDSRF) for remedial action (RA) at the Site.

Resolution Authorizing a Subgrant from the U.S. Environmental Protection Agency Brownfields Revolving Loan Fund in the Amount of \$200,000 for the Environmental Cleanup of the Knox Meadows Phase II Site in the North Camden Brownfield Development Area (Block 746, Lots 26 & 46 and a Portion of Lots 17, 18, & 25 of the City of Camden Tax Map)

**WHEREAS**, the City of Camden Redevelopment Agency (CRA) is charged with the duty of redevelopment throughout the City of Camden; and

**WHEREAS**, as part of the CRA's redevelopment duties, the CRA manages the City of Camden Brownfield Program including the planning activities, applying for and managing grants for investigation and remediation, and contracting for professional services and remediation work; and

WHEREAS, the Brownfield Program places priority on the investigation, remediation, and redevelopment of contaminated sites located in the North Camden Brownfield Development Area ("BDA"); and

WHEREAS, the CRA by Resolution 08-07-13C applied for and accepted a Brownfields Revolving Loan Fund ("RLF") Grant from the United States Environmental Protection Agency ("EPA") to establish a RLF and entered into EPA Cooperative Agreement BF96286914 (the "Cooperative Agreement"); and

**WHEREAS**, the Cooperative Agreement provides funding in the form of low to nointerest loans and subgrants that may be made available for environmental cleanup of brownfield sites in the City of Camden; and

WHEREAS, the Cooperative Agreement allows for a grant recipient to make subgrants to non-profits and other units of local government for eligible projects and uses, and

WHEREAS, a Portion of the Knox Gelatin Site known as the Meadows at Pyne Point Phase II designated as Block 746, Lots 26 & 46 and a Portion of Lots 17, 18, & 25 of the City of Camden Tax Map (the "Site"), is a City-owned parcel located in the North Camden BDA; and

WHEREAS, the Site is currently an active case with the New Jersey Department of Environmental Protection ("NJDEP") Site Remediation Program ("SRP"); and

WHEREAS, prior to the planned residential redevelopment of the Site, the environmental contamination at the Site must be remediated in accordance with NJDEP SRP requirements; and

WHEREAS, the CRA applied for State Hazardous Discharge Site Remediation Funds ("HDSRF") for a grant to pay for a portion of the remediation and related costs and the award of the grant is pending demonstration by the CRA that a match funding requirement can be met; and

**WHEREAS**, the EPA RLF subgrant, along with a \$200,000.00 EPA Brownfield Cleanup Grant previously awarded to the City of Camden, is needed to meet the pending HDSRF grant match funding requirement for the remediation of the Site; and

**WHEREAS**, the CRA, as the administrator of the City's Brownfield Program, also desires to manage, administer, and implement the EPA RLF subgrant for remediation of the Site; and

**WHEREAS,** by separate companion resolution presented at this meeting, the CRA will request the amendment of an existing shared services agreement with the City of Camden (previously authorized by Resolutions 12-14-16E and 06-10-20C) to provide for management of the subgrant by the CRA; and

**WHEREAS**, the proposed Subgrant was reviewed and recommended for approval by the CRA Finance Committee.

**NOW THEREFORE BE IT RESOLVED**, by the governing body of the City of Camden Redevelopment Agency that the Agency is hereby authorized to make a subgrant to the City of Camden in an amount not to exceed \$200,000.00 from the EPA Brownfields Revolving Loan Fund for the purpose of environmental remediation and related activities at the Knox Meadows Phase II Site; and

**BE IT FURTHER RESOLVED** that the Interim Executive Director, a duly authorized representative of the City of Camden Redevelopment Agency is hereby authorized and directed to execute a grant agreement and other documents and to take all actions and execute all documents necessary to carry out the purposes of this resolution.
